The Board invites and welcomes you to attend!

The Governor lifted the EO N-29-20 on September 30, 2021, which waived certain requirements of the Ralph M. Brown Act (Brown Act) in order to prevent gatherings and slow the spread of COVID-19, and required local public agencies that conduct public meetings virtually to allow members of the public to observe and address the meeting telephonically or otherwise electronically. California has moved Beyond the Blueprint to safely and fully reopen the economy. Restrictions for physical distancing, capacity limits on businesses and the county tier system ended on June 15, 2021. In accordance with new guidance from the California Department of Public Health, Board meetings will be open to the public and held at Light Of The Hills Lutheran Church, 3100 Rodeo Road, Cameron Park, 7:00 p.m., on the 3rd Thursday of every other month, in the Multi-Purpose room. The Agenda is posted at the green monuments by the entrance gates and on the CECSD website www.cameronstates.net 72 hours prior to the meeting. Meeting documents will be available on the website as well.

Temporary Gate Code for Events

If you are having a large event, or work done on your property, the District office can issue you a temporary gate entrance code to give to your gardener, contractor or guests. Call the District Office at 530-677-5889 to arrange for a temporary code. **Please request this code at least 7 days before needed.** This code will be disabled when no longer needed by the resident.

Gate Transmitters: Gate remotes can be purchased for \$45 at the District Office from the General Manager, Karen Moonitz. Please call her at: 530-677-5889 for an appointment.

Gate Transmitter Battery Replacement: Duracell security 21/23(12v NM21/A23) or another brand equivalent

Notices From the Board of Directors

1. With the amount of rain we just had several culverts and ditches in the District overflowed because of tree branch and leaf debris clogging them. **Please clear out the debris in and near your culverts, ditches in front of your property, and drainage pipes under your driveways!** Also, if you live near a creek, please remove any debris near the banks as rising water will carry away most anything near the creek and that can cause obstructions which will cause more flooding.
2. The Board is concerned that many signs in the District are being defaced, bent over or stolen. These signs cost the District hundreds of dollars to replace, which takes money

away from repairing roads! If you see anyone marking on, damaging, defacing, or stealing District signs, **please** report it to the District office at 530- 677-5889.

3. FYI: AT&T has changed dialing from a land line (yes some of us still have them!) in the 530 area code from 7 digits to 10 digit mandatory. This means you must now dial 1 + 530 + 7 digits when dialing from a 530 number to another 530 number.

El Dorado County Leash Law

This notice will keep repeating as many new families are moving into the District! The District Office has been receiving **many** complaints from residents about loose dogs and dogs off leash harassing their livestock and chasing them while walking, biking and riding horses in the District. We would like to remind all residents that according to El Dorado County Ordinance Code Title 6, Chapter 6.12 Section 6.12.070 - Running at large prohibited: (in part, look it up if you wish to see the full version): “No person owning or having control of any animal...shall permit such animal...to stray or run at large upon any...unenclosed private lot or other unenclosed private place in the County...” part A states: “**Any animal other than working animals shall be confined by the owner or his or her agent on a leash of not more than ten feet in length during any time the animal is removed from an enclosed private lot or enclosed private place.**” FYI if your loose dog causes bodily harm to human or animal, or even “engages in behavior that requires a person to take defensive action to prevent physical injury...or otherwise causes injury to any domestic animal” you are guilty of a misdemeanor and could be fined and sued. Upon conviction your dog could be deemed dangerous and/or vicious and if any other violation occurs after that designation, fees will be imposed upon you; you will be held liable for damages and your dog impounded and/or euthanized. **Please** keep your dogs confined at home and on leash while walking them.
